

MARSHAL'S REPORT
MARCH 12TH - APRIL 9TH 2008

- **March 14th 1:42 pm-** **The Hellgate/Superior area was closed and placed on interlodge due to increasing avalanche hazard.**

- **March 15th 6:30 am-** **Little Cottonwood Canyon was closed and interlodge placed into effect for avalanche control work until 7:34 am. At 11:42 am, a report was taken of a missing delivery package containing snowboard boots that had been shipped to one of the lodges.**

- **March 16th 8:51 am-** **A report was taken of a broken window/possible vandalism incident at a bypass road rental property.**

- **March 21st 9:38 am-** **A male who fled from ski lifts personnel was arrested and later released on a citation for theft of services after being caught skiing on someone else's pass. At 9:48 am, a minor traffic accident was investigated near the Rustler Lodge.**

- **March 22nd 6:29 am-** **A 30 year old patient with difficulty breathing was transported from the Rustler Lodge to a local hospital via ambulance.**

- **March 25th 2:34 pm-** **A 26 year old patient was flown by medical helicopter from the ski area to a local hospital following a skiing accident.**

- **March 26th 8:37 am-** **A traffic accident was investigated at the Powder Ridge driveway.**

- **March 27th 5:12pm-** **Another traffic accident was investigated in the Lower Albion parking area. At 5:46 pm, a report was taken involving damage to a snowcat in the Grizzly Gulch area.**

- **March 28th 2:03 pm-** **A report was taken of a vending machine that had been broken into at the Goldminer's Daughter Lodge.**

- **March 31st 6:25 am-** **The Superior/Hellgate area was temporarily closed due to avalanche hazard.**

- **April 3rd 3:15pm-** **A traffic accident was investigated on the bypass road.**

- **April 4th 2:06 pm-** An investigation is underway at one of the lodges where two employees became intoxicated and stole a number of pictures from the hallways. The employees were also seen feeding a coffee table into the lodge fireplace and burning it. One of the parties involved fled the state the following morning and our office is in the process of obtaining an arrest warrant. The pictures were recovered.
- **April 7th 8:23 am-** A traffic accident was investigated near the Alta Peruvian Lodge.
- **April 8th 1222 pm-** A report was taken of a lost wallet, cash, and credit card.
- **April 9th 1125 am-** A woman reported that her credit card number had been compromised and had been used for fraudulent internet purchases. The matter is under investigation.
