

**Marshal's Report**  
**December 14 - January 11, 2007**

December 15, 2006 11:13 pm the Alta deputy was called to assist the County Sheriffs with a fight in the Cliff Lodge at the Snowbird Resort. At 11:35 pm the Marshal's and UFA (Unified Fire Authority) were dispatched to the Goldminer's Daughter Lodge on a medical emergency involving a 31 year old male with a past history of suicidal tendencies. The patient had ingested a bottle of over the counter pain medication and alcoholic beverages. He was transported to the hospital by ambulance.

December 16, 2006 12:22 pm the Alta deputy assisted with a medical emergency at the Snowbird Resort. A sixty year old male patient with a heart condition was transported to the hospital by ambulance. 1:29 pm the deputy investigated a hit and run accident that occurred in the Goldminer's parking lot.

December 20, 2006 8:38 am the Marshal's Office investigated a car crash in the Flagstaff parking area

December 21, 2006 3:51 pm the Alta deputy assisted the County Sheriffs with a vehicle roll-over in the mid-canyon area of seven turns

December 25, 2006 10:44 am the deputy assisted the Alta Ski Patrol and UFA with a sledding accident that injured a 19 year old female, on a slope east of the Alta Lodge. The patient was transported by snowmobile to the Alta Clinic with back pain.

December 26, 2006 3:17 pm the deputy investigated another fender bender this one occurred in the lower Albion parking lot. 9:42 pm a driver was issued a citation when he made a poor judgment call and drove his car past the road closed sign in Grizzly Gulch and got stuck.

December 27, 2006 11:50 pm judgment on the part of another driver proved to be poor when he drove his car past the road closed sign and sunk it up to the door handles.

December 28, 2006 5:33 pm Deputy investigated another car crash in the lower Albion parking lot.

December 29, 2006 3:22 pm Alta Marshal's assisted with a person that had injured his ankle while skiing in the lower Flagstaff area. A UDOT avalanche forecaster quickly responded to the scene with a sled and transported the patient to the roadway where he was then taken to the Alta Clinic for treatment.

December 30, 2006 6:47 pm Alta deputy was dispatched to assist with a two car vehicle crash in the lower canyon that sent two injured people to the hospital. This crash also temporarily closed the canyon while the crash was cleaned up and investigated.

December 31, 2006 10:41 am the deputy on duty investigated a vehicle crash in the lower Albion parking lot. 11:39 am the deputy and UFA responded to a medical emergency at the Rustler Lodge involving a 31 year old female that had passed out in the bathroom. The patient was transported to the hospital by ambulance. 12:10 pm the deputy took a report from an employee at the Goldminer's Daughter Lodge that had prescription medication either lost or stolen.

January 1, 2007 10:00 am the Alta deputy assisted the County Sheriffs with a three car pile-up, mid-canyon near the Tanners Campground.

January 6, 2007 5:00 pm the Hellgate, Superior section of the Town of Alta was closed due to the avalanche hazard. The restriction was lifted at 4:38 am.
